Description: The [Law Society Referral Service](#) will help you find someone who provides legal services in the area of law that meets your needs. The service can also help you find a legal representative who meets specific requirements, such as a lawyer or paralegal who speaks a certain language, or a lawyer who accepts Legal Aid certificates. The request for service consists of an online form, where you can select the areas of law that your issue touches on. Once you have submitted your request, if a match is found, you will be given the name and telephone number of a lawyer or paralegal

and a referral number. The on-line request, the referral process, and your initial consultation of up to 30 minutes are free. If you do not have access to the internet, you can call the crisis line at 416-947-5255 (toll-free 1-855-947-5255) Monday - Friday between 9 am - 5 pm.

Use of the directory does not guarantee a free consultation. You will need to discuss legal fees directly with the lawyer/paralegal. The consultation is meant to help you determine your rights and options. You should not expect the legal representative to do any free legal work during this time - that is not the purpose of the consultation.

Le **Service de référence du Barreau** est un service en ligne. Ce service vous aidera à trouver un avocat ou d'un parajuriste qui pratique dans le domaine juridique qui répond à vos besoins.
